

Minutes of the Review Meeting on implementation of MPLADS with Nodal Secretaries of State Governments and UT Administrations held on 23rd February 2015 at VigyanBhawan, New Delhi.

Participation:

1. MPLADS review meeting was held on 23rd February 2015 at 11.30 A.M at Vigyan Bhawan, New Delhi. Hon'ble Minister, Ministry of Statistics & Programme Implementation chaired the meeting.
2. All States and Union Territories had been requested to participate. The list of participants is at **Annexure I**.

New integrated Website for MPLADS

- 3.1 Shri A. M. Varman, Senior Scientist (D) NIC made a detailed presentation on the new integrated MPLADS website during the pre-lunch session. The queries raised by some participants were replied to by him.
- 3.2 The new portal is required to be made fully functional by all the nodal district authorities at the earliest, as with effect from 01.04.2015 all MPLADS funds releases will be made through the new integrated portal.
- 3.3 Representatives of the State Governments requested for training. The Hon'ble Minister agreed to the request for training by the Ministry. The Ministry proposes to organize the training on new integrated MPLADS website during the month of March/April 2015 at NSSTA. The Nodal Secretaries were requested to ensure sending of the trainees as per the time table which will be informed to them in due course.

Discussions:

4. Discussion on the agenda items for the review meeting was taken up in the post-lunch session. Dr. Davendra Verma, Deputy Director General (PI) welcomed the Hon'ble Minister, MOSPI, Secretary (S&PI) and all the participants.

4.1. Secretary, S&PI in his opening remark emphasized the need to expedite utilization of MPLADS funds for timely release of pending installments, particularly that of 16th Lok Sabha Members. He also urged the Nodal Secretaries to direct the nodal district authorities of the 15th Lok Sabha MPs to furnish necessary documents/certificates to the Ministry for releasing the pending installments. He urged the Nodal Secretaries to ensure that District Authorities should complete all works within 18 months from the date of demitting office in case of Rajya Sabha MPs or dissolution of the Lok Sabha and close the account of the concerned MP/MPs after completing all other formalities in 3 months after distribution of balance funds as per para 4.10.1 of the Guidelines on MPLADS. He also requested Nodal Secretaries to expedite the replies to outstanding C&AG Audit Paras and Action Taken Notes on Third Party Physical Monitoring Reports in a time bound manner.

4.2 The Hon'ble Minister for Statistics & Programme Implementation in his address emphasized the need to improve utilization of MPLADS funds. He felt that 90% cumulative utilization percentage is not very satisfactory for a scheme which is in operation continuously for a long time with non lapsable funds. The Hon'ble Minister mentioned that MPLADS funds are available for developmental works to States over and above what they get and urged the Nodal Secretaries to work towards removal of bottlenecks to hasten up implementation of MPLADS. He observed that feed back received by him from MPs indicate delay at the district level in implementation of MPLADS. He urged the need for district authorities to become more sensitive and ensure expeditious implementation of the scheme with probity and transparency. He exhorted the participants to work in a manner that results should be visible on ground.

5. DDG (PI), thereafter, led the state-wise review in the following areas:-

Review of the minutes of the last review meeting held on 20.11.2013

5.1 Regarding C&AG Audit Para No. 3.4 for utilization of MPLADS funds beyond the prescribed limit of Rs. 25 lakh stipulated for trusts and societies in Goa,

the representative of Goa mentioned that action on the issue is being taken and report will be furnished within 30 days to the Ministry.

5.2 Regarding the suggestion to increase the ceiling of Rs. 50,000/- on POL for bigger states, it was informed that as the number of MPs in bigger states are more so the bigger states receive more amount as Administrative Expenses and consequently have more amount for expenses towards POL. Therefore, it is felt that increasing the ceiling of Rs. 50,000/- on POL for bigger states is not warranted.

5.3 Regarding Internal Audit of MPLADS in the districts by Controller of Accounts in the Ministry, the participants were informed that the matter is under examination in consultation with Ministry of Law & Justice, Ministry of Finance and C & AG.

5.4 In respect of the suggestion that the MPs should make their recommendations in a comprehensive manner within the first 2-3 months of the year rather than making the recommendations from time to time, the participants were informed that the Guidelines on MPLADS do not provide for any such restrictive period of time for making recommendations by Hon'ble MPs. The Hon'ble Minister intervened to suggest that preparation of a list of shelf of projects in advance by the nodal district authorities could speed up the recommendations from Hon'ble MPs.

Slow release and slow utilization

6. Timely and regular utilization of funds is an essential requirement, the importance of which cannot be over emphasized. Implementation of the scheme is with the State Governments. Request was, therefore, made to ensure (a) regular and timely utilization of funds (b) submission of necessary documents and certifications for further releases.

6.1 The position of State-wise pending installments for releases is given at **Annexure-II**.

Closure of Accounts of 14th Lok Sabha MPs and Ex-Rajya Sabha MPs

7. Nodal Departments of the States/UTs for MPLAD Scheme were earlier requested to collect the information about the unspent/uncommitted balances available with the District Authorities after completion of all sanctioned works of 14th Lok Sabha and complete the process of distribution of unspent/uncommitted balances by 31st December 2010.

7.1 All the states, except Bihar, have completed the process of distribution of unspent funds among the sitting MPs of 15th Lok Sabha. The representative of Bihar informed that process of distribution of unspent funds and closing of accounts is underway and the same would be completed at the earliest. The Hon'ble Minister desired that the same may be completed within a month's time under intimation to the Ministry.

7.2 All Nodal State Authorities were requested to issue directions to all the District Authorities to send Monthly Progress Reports showing **ZERO** unspent balance along with the Final Utilization Certificate and Final Audit Certificate for closure of 14th Lok Sabha accounts.

7.3 The representatives of State Governments of Uttar Pradesh and Tamil Nadu requested the list of 14th Lok Sabha MPs and Ex-Rajya Sabha MPs whose accounts are to be closed may be uploaded on the website of MPLADS. The Ministry assured that such a list will be uploaded on the website shortly.

Completion of works of 15th Lok Sabha MPs and closure of accounts

8.1 Nine months have already passed since the dissolution of 15th Lok Sabha. The State Governments have to ensure that the eligible works recommended by the 15th Lok Sabha MPs till the last day of their term are to be executed within next 9 months and accounts are to be closed in another 3 months time.

Pending CAG audit paras

9. Status of C & AG performance audit report no. 31 is available in **Annexure-III**. Replies received from the 17 States/UTs have been found to be incomplete in respect of paras mentioned against each State/UT.

9.1 The States were requested to examine the irregularities pointed out by the C&AG expeditiously and to get the allegations enquired, take appropriate action and furnish factual and action taken report to the Ministry on PRIORITY, to enable the Ministry to furnish Action Taken Notes to C&AG.

Action Taken Replies – PAC 55th Report on MPLAD Scheme – additional list of points:

10. The Government of West Bengal was requested to keep the Ministry continuously informed in the matter of PAC Para 11 (C&AG Para 4.4.1).

10.1 The Andaman & Nicobar Administration and the Government of Telangana were requested to specify the amount recovered and the amount yet to be recovered with reference to PAC Para 6 (C&AG Para 6.6).

Action taken on third party physical monitoring reports

11. During the year 2012-13, the work of physical monitoring was undertaken in North and West Zone (50 districts in each zone) by Agricultural Finance Corporation (AFC).

11.1 Copy of the report along with comments of the Ministry have been sent to respective District Authorities of North and South Zone in November-December 2013 for taking corrective action and to submit Action Taken Reports (ATRs) to the Ministry.

11.2 ATRs are yet to be received from 30 District Authorities in North Zone and 35 District Authorities in West Zone inspite of repeated reminders.

11.3 It was urged that appropriate action on the reports may be taken urgently in time-bound manner and the Action Taken Reports may be sent to the Ministry by the defaulting district authorities.

Process Re-Engineering of Implementation of the MPLAD Schem

12. DDG informed the representatives of the State Governments that PMO has desired that the idea of process re-engineering in the Implementation of the MPLAD Scheme may be explored, to address various issues on a systemic instead of case-to-case basis. This Ministry is already in the process of implementation of new integrated MPLADS portal. When fully operationalized, this portal will provide a centralized data base to all stake holders including MPs and citizens. This portal will also provide citizen centric solution and has also the provision of communication between MPs, citizens and authorities. The Hon'ble Minister asked the representatives of the State Government to express their views on redesigning the implementation process of MPLAD Scheme and share ideas/views directly with him and for the purpose he provided his personal e-mail address to them. He urged them to furnish their suggestions within one month.

Issues raised by States

13. The representatives of Tamil Nadu and Karnataka requested to permit installation of fixed RO Plants under MPLADS. They were informed by the DDG (PI) that this is already permissible under MPLADS.

13.1 Principal Secrety, Government of Bihar informed that at least 5 visits of concerned Project Engineer are required at the state of planning and 5 more visits are required at the time of actual execution. The sites of the works are scattered over large area in the districts. Therefore, the ceiling of Rs. 50,000 on POL needs to be increased for bigger States. Similar views were expressed by the

representatives of Karnataka Government. The matter has already been examined and the views of the Ministry are given in para 5.2 of the minutes.

13.2 Representative of Meghalaya Government pointed out that the smaller States that do not have adequate technical staff need to hire employees like Junior Engineers on contract basis. DDG(PI) clarified that hiring of contractual employees for MPLADS works is permissible from 2% Administrative Expenses.

The meeting ended with vote of thanks to the chair.
