Sub: - Erection of Plaque for the works executed under MPLADS.

Sir,

- 1. Para 3.22 of the Guidelines on MPLADS provides that:
 - "3.22 As soon as a work under the Scheme is completed, it should be put to public use. For greater public awareness, for all works executed under MPLADS a plaque (stone/metal) carrying the inscription 'Member of Parliament Local Area Development Scheme Work' indicating the cost involved, the commencement, completion and inauguration date and the name of the MP sponsoring the project should be permanently erected". A sample Plaque has been provided in Annexure XI of the guidelines.
- 2. A number of complaints have been received in the Ministry regarding non erection of plaques for the works executed under MPLADS. The agencies that have carried out third party physical monitoring have also pointed out that in the absence of plaques it becomes difficult to ascertain which works have been executed under MPLADS as works under a number of schemes are executed by the District Authorities.
- 3. The matter has been reviewed at the highest level .Non erection or irregular erection of plaques is violation of the provisions of the guidelines and defeats the purpose of identification of MPLADS works for common public. After execution of the work under MPLADS, the plaque should be invariably

future it is brought to the notice of the Ministry that plaque with inadequate information or that no plaque has been erected after completion of a work under MPLADS, it would be referred to the State Government with request to fix accountability and take departmental action for non compliance of the guidelines.

- 4. It is, therefore, reiterated that the provisions of the Guidelines on MPLADS in respect of erection of Plaques on MPLADS work sites should be followed scrupulously.
- 5. This issues with the approval of Competent Authority.
