**Sub: MPLADS – Development of Areas inhabited by
Scheduled Castes and Scheduled Tribes – regarding.**

Sir / Madam,

I am directed to invite your attention to Para 2.5 of MPLADS Guidelines, 2005 wherein it has been laid down that the MPs are to recommend every year such works costing at least 15% of MPLADS funds for areas inhabited by Scheduled Caste population and 7.5% for areas inhabited by Scheduled Tribe population. In other words, permissible works costing not less than Rs.30 lakh out of the annual allocation of Rs.2 crore per MP shall be recommended for areas inhabited by SC population and Rs.15 lakh for areas inhabited by ST population. In case, a constituency does not have any ST inhabited area, such funds may be utilized in SC inhabited areas and vice-versa. It shall be the responsibility of the District Authority to enforce this provision of the Guidelines.

2. This matter has been discussed in detail in various fora. However, it has come to the notice of this Ministry that the above stipulation is not being adhered to by most of the District Authorities.

3. It is, therefore, once again requested that necessary action may be taken to persuade MPs to recommend works for areas inhabited by Scheduled Caste and Scheduled Tribe Population as per the Guidelines on MPLADS, under intimation to this Ministry.


