Subject : **Distribution of Unspent/Un-released /funds not committed for the eligible recommended work of the predecessor MPs upto 14th Lok Sabha –regarding**

Sir/Madam,

Please refer to this Ministry's letter No C/7/2006-MPLADS dated 10.5.2010 regarding distribution of balance unspent funds not committed upto 14th Lok Sabha amongst sitting members of 15th Lok Sabha. This exercise was required to be completed by end of February, 2011.

2. It has been noticed that only partial implementation of the re-distribution of funds amongst the 15th Lok Sabha MPs has been effected till date despite repeated requests to complete the process of distribution of unspent funds not committed and close the bank accounts upto 14th Lok Sabha. References have recently been received from some State Nodal Departments/District Authorities seeking clarification in respect of the process for distribution of balance unspent amount still pending for distribution pertaining to 14th Lok Sabha.

3. The matter has been examined in this Ministry in detail and it has been decided that unspent MPLADS funds belonging to 14th Lok Sabha MPs be passed on to Nodal districts of the 15th Lok Sabha MPs for the 18 states (**Andhra Pradesh, Bihar, Chhattisgarh, Delhi, Gujarat, Haryana, Jharkhand, Kerala, Karnataka, Madhya Pradesh, Maharashtra, Odisha, Punjab, Rajasthan, Tamil Nadu, Uttrakhand, Uttar Pradesh and West Bengal**) where the distribution could not be fully affected during the tenure of the 15th Lok Sabha as per this Ministry's Circular No C/7/2006-MPLADS dated 10.5.2010. The Balance amount (after the eligible validly recommended works are satisfied) left in the 15th Lok Sabha MPs accounts should be passed on to the 16th Lok Sabha MPs account as per procedure given in Para 4.7 of the Guidelines on MPLADS.

4. The exercise of distribution of unspent of funds as per procedure mentioned above may be completed at the earliest under intimation to this Ministry.
