**Subject: Details of Master trainers for implementing the Revised procedure of fund-flow under MPLADS for each State – Regarding;**

Madam/Sir,

As you are aware, a web-solution <https://mplads.sbi> for implementing the Revised procedure of flow of funds (CNA model) has been developed, in collaboration with the State Bank of India, and in accordance with the instructions issued by Ministry of Finance, Department of Expenditure vide their O.M. No. 1(18)/PFMS/FCD/2021 dated 09.03.2022. All processes under MPLAD Scheme, starting from work recommendation by Hon'ble MPs, Administrative sanction of the projects, authorization of fund flows, payment to the vendors, etc. will be done through the Web-Solution as per the revised procedure, w.e.f. 01<sup>st</sup> April 2023.


2. In this connection, it is necessary to train and develop **master trainers** among the State/UT officials to develop the capacity of the States/UTs for efficient implementation of the scheme through CNA. The number of Master trainers required for each States are as follows:

State/UT	No. of Master trainers required
Uttar Pradesh, Maharashtra, Bihar, West Bengal, Madhya Pradesh, Tamil Nadu, Rajasthan, Karnataka, Gujarat, Andhra Pradesh, Odisha, Telangana, Kerala, Jharkhand, Assam, Punjab, Chhattisgarh, Haryana, Jammu and Kashmir	Atleast 5.
Delhi, Uttarakhand, Himachal Pradesh, Tripura, Meghalaya, Manipur, Nagaland, Goa, Arunachal Pradesh, Puducherry, Mizoram, Chandigarh, Sikkim, Daman and Diu and DN Haveli, A&N Islands, Ladakh, Lakshadweep.	Atleast 2.

3. Hence, it is requested to furnish the details of the Master Trainers, as per annexure I, who will get trained intensely from the Ministry and will act as the resource person for respective States/UTs.
