Subject: Revised procedure for flow of funds under Central Sector Schemes – Relaxation sought by Ministry of Statistics & PI (MoSPI) regarding MPLADS Scheme.

The undersigned is directed to refer to Additional Secretary, MoSPI DO letter No. C-65/2019-MPLADS dated 28th March, 2023 on the above mentioned subject. The matter was discussed with officials of MoSPI on 28th March, 2023.

2. The matter has been examined in this Department and following clarifications/relaxations are provided –

- i. With effect from 1st April, 2023, MPLADS scheme shall be implemented in CNA model only as per DoE's guidelines dated March 9, 2022.
- ii. Relaxation from provision of para 3(xi) and 3(xii) of DoE's guidelines dated 9th March, 2022 regarding return of unspent balances by all the SAs to the CNA account is granted to MPLADS scheme of MoSPI till 31st March, 2024. MoSPI may release funds to the CNA account and issue authorization to incur expenditure to an SA without waiting for that SA to return the unspent funds to the CNA account. However, MoSPI will ensure that unspent funds in old bank account of an SA is less than Rs. 1 crore before issue of new assignment to that SA under CNA system.
- iii. PFMS division, O/o CGA to ensure that the existing facility to monitor unutilized amount in old bank accounts of MPLADS scheme through EAT module is available to MoSPI after onboarding of the scheme on CNA module.
- iv. Other conditions stipulated in DoE's OM dated 27th September, 2022 shall be strictly adhered to.
- 3. This issues with the approval of competent authority.

Subject: Revised procedure for flow of funds under Central Sector Schemes – Relaxation sought by Ministry of Statistics & PI (MoSPI) regarding MPLADS Scheme.

The undersigned is directed to refer to the meeting held by Finance Secretary & Secretary (Expenditure) with Secretary, MoSPI, AS (PFC-II), DoE and AS (PFS), DoE on 20th April, 2023 regarding the relaxation sought by MoSPI for MPLADS scheme.

2. The revised procedure for flow of funds for Central Sector Schemes came into effect from 1st April, 2022. However, in view of the difficulties faced by MoSPI in implementing the revised procedure, relaxation till 31st march, 2023 was granted to MPLADS scheme of MoSPI from the provisions of DoE's guidelines dated 9th March, 2022. Further, keeping in mind the sensitive nature of the scheme, this Department issued relaxations/guidelines dated 27th September, 2022 and 31st march, 2023 to further facilitate the on boarding of MPLADS scheme onto the CNA platform. A meeting on 20th April, 2023 was held to discuss further relaxation sought by MoSPI for MPLADS scheme.

3. The matter has been examined in this Department and it has been decided that the condition enumerated in para 2(ii) of DoE's guidelines dated 31^{st} march, 2023 that -

"MoSPI will ensure that unspent funds in old bank account of an SA is less than Rs. 1 crore before issue of new assignment to that SA under CNA system"

may be read as

"MoSPI will ensure that both unspent funds and unsanctioned funds in old bank account of an SA are less than Rs. 3 crore and Rs. 1 crore respectively before issue of new assignment to that SA under CNA system"

4. MoSPI should ensure strict compliance of other provisions of DoE's OMs dated 27th September, 2022 and 31st March, 2023.

5. This issues with the approval of competent authority.
