Subject:- Construction of Open Air Gym through MPLADS funds in East Delhi-Complaint of Sh. Maheish Girri, Hon'ble MP (LS) - regarding.

Sir.

I am directed to forward herewith a copy of complaint number MPED-34488-8/CAHA dated 18.10.2017 of Sh. Maheish Girri, Hon'ble MP (East Delhi Lok Sabha Constituency), raising certain queries therein.

- It may be mentioned that as per Para 3.5 of the Guidelines on MPLADS where the 2. District Authority considers that a recommended work cannot be executed due to some reason, the District Authority shall inform the reason to the MP concerned, under intimation to the Government of India and the State/ UT Government as early as possible but not later than 45 days from the date of receipt of the proposal.
- It may also be mentioned that Para 3.12 of the Guidelines on MPLADS provides that all recommended eligible works should be sanctioned within 75 days from the date of receipt of the recommendation, after completing all formalities. The District Authority shall, however, inform MPs regarding rejection, if any, within 45 days from the date of receipt of recommendations, with reasons thereof.
- Also, Para 3.13 of the Guidelines on MPLADS states that the sanction letter/ order 4. shall stipulate a time limit for completion of the work to the Implementation Agency. The time limit for completion of the works should generally not exceed one year. In exceptional cases, where the implementation time exceeds one year, specific reasons for the same shall be incorporated in the sanction letter/ order. The sanction letter/ order shall also include a clause for suitable action against the Implementation Agency in the event of their failure to complete the work within the stipulated time as per the State Government Procedure.

5. Prima facie it appears to be a case of violation of the above of Guidelines α MPLADS by the District Authority. It is requested to get the matter enquired and furnish ε., factual/ action taken report to this Ministry so that the Hon'ble MP can be apprised of accordingly.
