Subject: Reconstruction/rehabilitation works to be undertaken in the Chennai Floods affected areas of Tamil Nadu out of the MPLADS funds contributed by Members of Parliament from Rajya Sabha -reg.

Sir,

I am directed to refer to this Ministry's earlier letter of even no. dated 15.09.2016 wherein it was requested to convey the approval of Hon'ble Committee on MPLADS (Rajya Sabha) for taking up the following works out of the funds consented by Rajya Sabha Members:-

- i. works mentioned at Sr.no. 12 to 37 amounting to Rs.696.00 lakh in Thiruvallur District furnished by the State Govt. vide letter No.1380/2016/NEDM- 3 dated 22.01.2016.
- ii. all works(except two works of construction of Protective wall in Thoothukudi block amounting to Rs. 65.00 lakh mentioned at sl.no. 1 & 2 of page 11 of the list of works enclosed with letter no. 1380/16/NEDM-3 dated 07.06.2016), amounting to Rs.1470.64 lakh in Thoothukudi District.


2. In this regard, it is to mention that Smt.Sasikala Pushpa, Hon'ble MP (RS) who had earlier consented an amount of Rs. 1 core for the rehabilitation/reconstructions works in Tamil Nadu floods affected areas has now desired to withdraw the same (copy enclosed).

3. As per the provisions in Para 3.15 of the Guidelines on MPLADS, the work once recommended by the MP and sanctioned by the District authority may be cancelled if so desired by the MP, only if the execution of the work has not commenced and the cancellation does not lead to any contractual financial liability/cost on the Government. Hence, the Hon'ble MP can withdraw her consent as the rehabilitations works to be taken up from the funds consented by Rajya Sabha members are yet to be sanctioned/implemented by the State Government of Tamil Nadu.

4. In view of the above, it is requested to convey the approval of the Hon'ble Committee on MPLADS (Rajya Sabha) for taking up the following works amounting to Rs.2066.64 lakhs out of the funds consented by Rajya Sabha Members:-

- i. works mentioned at Sr.no. 12 to 37 amounting to Rs.696.00 lakh in Thiruvallur District furnished by the State Govt. vide letter No.1380/2016/NEDM- 3 dated 22.01.2016.
- ii. all works (except two works of construction of Protective wall in Thoothukudi block amounting to Rs. 65.00 lakh mentioned at sl.no. 1 & 2 of page 11 and four works of construction of Drainage in Tiruchendur block amounting to Rs.100 lakh mentioned at sl.no. 8-11 of page 07 of the list of works enclosed with letter no. 1380/16/NEDM-3 dated 07.06.2016), amounting to Rs.1370.64 lakh in Thoothukudi District.
