
I am directed to refer to your letter No. 287/DP/O/32S-10/2012(Pt) dated 10.02.2016 wherein it was mentioned that Prof. Jogen Chowdhury, Hon'ble MP(Rajya Sabha), West Bengal recommended an amount of Rs. 59,31,536/- for "Development of Water Body at Sweet Land bank Plot" in ward no. 92 & 104 under Borough-X & XI of KMC.

2. Kolkata Municipal Corporation vide their letter dated 10.11.2016 has stated that the recommended work is restoration work in nature and the land does not belong to Government or Trust/society.

3. Regarding admissibility of the recommended work of the Hon'ble MP, the advice of this Ministry has already been conveyed vide letters dated 17.08.2016 and 27.02.2017 to the Department of Planning, Government of West Bengal and the Hon'ble MP.

4. Now, since the Hon'ble MP(RS) vide his letter dated 29.09.2016 addressed to the Director General, Kolkata Municipal Corporation has stated that the said land is taken over by the Kolkata Municipal Corporation (KMC) by invoking Section 17A of the west Bengal Fisheries Act, 1993(amended), it is requested to kindly direct the concerned authority to examine the matter and take decision as per provisions in the Guidelines on MPLADS under intimation to the Hon'ble MP and this Ministry.
