2. All District Collectors / District Magistrates / Deputy Commissioners of Andhra Pradesh and Telangana States.

Sub: - Release of MPLADS funds to the Rajya Sabha MPs of Andhra Pradesh and Telangana States.

Sir,

Consequent upon bifurcation of erstwhile unified Andhra Pradesh State, as per notification of Rajya Sabha dated 30.05.2014, out of 18 Rajya Sabha MPs 7 MPs have been deemed elected to fill the 7 seats allotted to the State of Telangana, with effect from 02.06.2014.

- 2. It has, therefore, been decided that MPLADS funds, including the installments pending prior to bifurcation, will be released only to the new Nodal Districts chosen by the MPs in their newly allotted States.
- Erstwhile Nodal Districts to which the funds were being released before bifurcation are required to transfer the balance funds in the MPLADS accounts of the concerned MPs to the new Nodal Districts chosen by the MPs along with records of all eligible recommendations and sanctioned works.
- 4. The new Nodal Districts will release funds in respect of already recommended eligible works, including already sanctioned works (upto 02.06.2014), to the Implementing Districts and the erstwhile Nodal Districts (now Implementing District) even if located in the other State. These Implementing Districts will be required to complete the works in a time-bound manner and send Utilization Certificates and Work Completion Certificates and Audit Certificates to the new Nodal Districts. After execution of the works, the Implementing Districts will be required to transfer the balance funds to the new Nodal Districts.

- 5. The recommendations of works made by the MPs after bifurcation of the State i.e. 02.06.2014 to the erstwhile Nodal Districts will not be eligible and will not be considered/implemented.
- 6. This issues with the approval of Competent Authority.
